- 2. Sealed Tenders will be opened on 06-10-2021 at 02:30 PM at NIOS Regional Centre Chandigarh in the presence of dealers or their authorized representative.
- 3. The approximate quantity of all the used/unused answer books is around 20 Tons. The highest rate quoted will be considered for acceptance having all other conditions at par. Rates quoted will be inclusive of GST. Moreover rates quoted will be valid for 6 months.
- 4.
