### Notification -9/2023

In pursuance to the recommendations of the committee and subsequent approval of the Competent Authority NIOS, the scheme of Formative Assessment (FA), the internal marks & passing criteria of integrated Vocational Subjects has been revised. The revised scheme of Formative Assessment (FA), the internal marks & passing criteria of integrated Vocational Subjects will be implemented from Academic Session 2023-2024 Stream-1 (Block-I) March/April -2024 Public Examination onwards.

The revised scheme of Formative Assessment (FA) and the internal marks & passing criteria of integrated Vocational Subjects are as under:

- 1. The facility of appearing in Formative Assessment (FA) sessions shall be provided throughout the five years of admission period.
- 2. The current practice of maintaining records of both Formative Assessment and Summative Assessment (SA) shall continue.
- 3. The learners who missed the opportunity to appear in FA will be allowed to reappear in FA as per the schedule to be prepared by Department of (Student Support Services).
- 4. The learners will appear in the FA at the allotted study centre.
- 5. The study centre shall conduct five practical sessions of FA and award the marks as per the existing criteria.
- 6. The awards of FA will be uploaded by the study centres only through online mode.
- 7. The facility to reappear in FA sessions shall be allowed only one time during the five years of admission period.
- 8. The learner shall pay the examination fee (per subject) to reappear in the practical (FA) component.
- 9. The year of passing shall remains same if the learner's overall passing year remains unchanged after adding the new FA marks. If the learner is declared as pass after adding the new FA marks then the passing year shall be changed as per the current exam.
- 10. The internal marks of integrated vocational subjects shall be shown separately.

There will be no separate passing criteria for internal component of integrated vocational subjects.

12. The passing criteria of integrated vocational subjects shall be at par with Secondary and Sr. Secondary academic subjects.

13. The awards of internal marks of the vocational subject shall be retained and not be allowed to re-appear in case the learner missed the opportunity during the first year of admission.

14. The unsuccessful learners of practical components of integrated vocational subjects shall be allowed to appear in practical components

only.

15. The awards of practical and internal assessment in vocational subject are to be uploaded separately by the AI/ AVI/ SAIED immediately after the conduct of practical examination.

16. The learners may be assessed for internal assessment (IA) as per guidelines developed by the Vocational Education Department.

- The learner shall pay the examination fee (per subject) for March/April 2024 Examination to reappear in the practical (FA) component.
- The learners will be allowed to reappear in FA as per the schedule to be prepared by the Department of Student Support Services.
- The learners will appear in the FA at the allotted study centre.
- The study centre shall conduct five practical sessions of FA and award the marks as per the existing criteria.
- The awards of FA will be uploaded by the study centres only through online mode.
- 6. The year of passing shall remain same if the learner's overall passing year remains unchanged after adding the new FA marks. If the learner is declared as pass after adding the new FA marks then the passing year shall be changed as per the current exam.

It may also be noted that the facility of reappearing in Formative Assessment (FA) is only available to those, who missed their FA in the first year of Admission, as per existing NIOS norms. The learners, who have already appeared in FA and awarded marks, are not allowed to reappear.


### Points to remember

# The learners, who have already appeared in FA and awarded marks, are not allowed to reappear in FA.

- 1. The learner shall pay the examination free (per subject) for April 2024 Public Examination of Secondary and Senior Secondary course to reappear in the practical (FA) component. Process of submitting the exam fee for reappearing in Formative Assessment (FA) is given below.
- 2. The learners shall be allowed to reappear in FA as per the schedule to be prepared by the Department of Student Support Services
- 3. The learners shall appear in the FA at the allotted study centre/PCP centre
- 4. The study centre/PCP centre shall conduct five practical sessions of FA and award the marks as per the NIOS existing criteria
- 5. The awards of FA shall be uploaded by the study centre/PCP centre only through online mode
- 6. The year of passing shall remain same if the learner's overall passing year remains unchanged after adding the new FA marks. If the learner is declared as PASS after adding the FA marks then the passing year shall be changed as per the current exam.


# Process for submitting the exam fee for appearing in five PCPs for Formative Assessment (FA)




Learners shall apply for reappearing in Formative Assessment (FA) in the practical subject(s) for which they are eligible but were not able to attend five PCPs for FA and missed the PCPs/FA during the first year of admission.




Click on "Submit Exam Fee for Formative Assessment (FA) sub-menu




After clicking on the link, screen as shown below will appear. Enter enrollment number:




After entering the valid enrollment number, details of the learner along with the Practical Subjects opted by the learner will be displayed for selection. Carefully read the eligibility and important points. Select the subjects for which you missed to appear in PCP and FA marks were not awarded.



Click on Submit button to continue else click on Reset to remove the selection.



Total fee to be paid by the learner will be displayed. Select the Payment Gateway and then click on Make Payment button.



From the screen, choose the desired option to make the payment. Payment can be done using any available QR code, debit/credit card, net banking etc.
