The NIOS conducts Public examination twice a year i.e., in the month of April-May and October-November. Accordingly, Public Examination (Theory) of Secondary and Senior Secondary courses for **April**, **2026** is likely to commence w.e.f. first week of April 2026. The exam centres shall be fixed at Kendriya Vidyalayas, Navodaya Vidyalayas, Government / Government aided / Private Schools / Colleges / Institutions affiliated with CBSE / ICSE / State Boards / Universities as per the exam Bye-laws of NIOS.

In view of this, Regional Directors are to make concerted efforts to motivate the Principals / Heads of the Schools / Colleges under their region to apply online to become examination centres of NIOS.

The URL for exam centre registration is https://exams.nios.ac.in. The portal will remain open for online submission of application from 01.12.2025 to 31.12.2025. The norms for the exam centre are available on the NIOS website.

The Bank Undertaking Proforma has to be filled up and to be uploaded at the given link. The original Centre Acceptance form along with the Bank Undertaking complete in all aspects is required to be submitted immediately to the concerned Regional Centre of NIOS.

The Schools / Colleges already registered previously have to give their consent with option to update their details and upload a fresh / current 'Bank Undertaking'.

The examination centres shall be fixed by NIOS as per the exiting norms at the time of fixation and does not give any right or priority to any schools / institutions at this stage.
