2.	For all eligible learners with late fee of Rs. 150/- per subject	16 th January, 2026 to 20 th January, 2026 (with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1600/-per learners	21 st January, 2026 to 25 th January, 2026 (with consolidated late fee)
The examination fee payment schedule for the learners registered for October-November, 2025 examination will be notified after the declaration of result.
