The Schedule for registration and payment of examination fee is as under:

1.	For all eligible learners	1 st January, 2026 to 15 th January, 2026 (without late fee)
2.	For all eligible learners with late fee of Rs. 150/- per subject	(with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1600/-per learners	21 st January, 2026 to 25 th January, 2026 (with consolidated late fee)

The examination fee payment schedule for the learners registered for October-November, 2025 examination will be notified after the declaration of result.

All the Regional Directors are to note for compliance and also directed to intimate to the concerned AVIs for submission of Examination fee of Vocational Education Courses within the stipulated time.
