

In continuation to the Notification No. 56 dated 19th November, 2024 regarding submission of exam fee for public examination of NIOS Secondary and Senior Secondary Courses **April/May 2025**, the schedule for registration and fee collection for all **registered learners of October/November, 2024 Examination** is as under:

1.	For all registered learners of October/November, 2024 Examination	Without late fee.	28th January, 2025 to 07th February, 2025.
2.		With Late Fee of Rs. 150/- per Subject	08th February, 2025 to 12th February, 2025.
3.		With consolidated late fee of Rs. 1600/- per learner	13th February, 2025 to 17th February, 2025.

The learners of Senior Secondary Course must ensure compulsory gap of two years from the Block/Session and year of passing the Secondary Examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming **April/May 2025** Examinations. The learners may therefore carefully select the subject(s) accordingly to register for the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: sdmis.nios.ac.in.
