The Personal Contact Programme (PCP) for the Academic session 2025-26, Stream-1(Block-I) is going to commence from 1st Sunday of November, 2025 i.e 02.11.2025 Accordingly, all Regional Directors are requested to inform all the AIs under their jurisdiction to upload the PCP Schedule on the portal under the link of AIs (study centre) for the dissemination among the learners. Further, the AIs be strictly instructed to adhere to the aforesaid instructions and non compliance of uploading of the PCP schedule may be presumed that the AI is inactive and thereafter, the Regional Directors shall initiate the process of de-activation in respect of these AIs.

Academic Facilitators may be deputed to monitor the conduct of PCP in all AIs and feedback to be taken from the Academic Facilitator for necessary action.

If the study centre of the learner is changed due to any reason, a proper communication to this effect be shared either through letter,e-mail or SMS to the learner regarding allotment of new AI (study centre).

The PCP grant will be released to the study centre only on uploading of PCP Schedule and conduct of PCP classes etc.

The above instructions be strictly complied with and the action taken report may also be intimated to this office latest by 15.11.2025 positively.
