The next Public Examination of NIOS for Secondary and Senior Secondary courses is scheduled to be conducted during **March/April 2026**. The schedule for registration and payment of examination fee for Secondary and Senior Secondary Courses of this examination is as under:

1.	For learners enrolled in Stream-I, Block-I for March/April 2026 Examination.	21 st November, 2025 to 20 th December, 2025
2.	For eligible learners for examinations prior to September/October 2025 Public Examination.	
WITH LATE FEE OF Rs. 150/- PER SUBJECT		
3.	For all eligible learners as mentioned at Sl. No. 1 and 2 above.	21 st December, 2025 to 31 st December, 2025
WITH CONSOLIDATED LATE FEE OF Rs. 1600/- PER LEARNER		
4.	For all eligible learners as mentioned at Sl.No.1 and 2 above.	01 st January, 2026 to 10 th January, 2026
The examination fee payment schedule for the learners registered for September/October 2025 examinations will be notified after the declaration of result.		

The learners of Senior Secondary Course must ensure compulsory gap of two years from the block/session and year of passing the Secondary examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming **March/April 2026** examinations. The learners may therefore carefully select the subject(s) accordingly to appear in the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: sdmis.nios.ac.in.
