This is in continuation to the Notification No. 81/2025 dated 30.12.2025 regarding scheduled for registration and payment of examination fee for April-May 2026 Vocational Education Courses exam. In this regard, revised scheduled for registration and payment of examination fee is as under:

The NIOS Examination of Vocational Education Courses is scheduled to be conducted during April-May, 2026. The Examination fee for same will be accepted only through online mode. The examination fee is Rs. 400/- per subject/Module (Inclusive for Theory, Practical, and Internal Assessment, if any).

The revised Schedule for registration and payment of examination fee is as under:

Sl. No.	Fee Schedule	
1.	For all eligible learners	1 st January, 2026 to 15 th February, 2026 (without late fee)
2.	For all eligible learners with late fee of Rs. 150/- per subject	16 th February, 2026 to 20 th February, 2026 (with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1600/- per learners	21 st February, 2026 to 25 th February, 2026 (with consolidated late fee)

The learners who registered in October, 2025 session will be covered in the same exam fee schedule after the declaration of result.

All the Regional Directors are to note for compliance and also directed to intimate to the concerned AVIs for submission of Examination fee of Vocational Education Courses within the stipulated time. No offline fee will be accepted. The Regional Directors are requested to upload the Notification on their Regional Centre's website and also issue Press Release in the local dailies.
