The learners of Senior Secondary Course must ensure compulsory gap of two years from the Block/Session and year of passing the Secondary Examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming **April/May, 2026** Examinations. The learners may therefore carefully select the subject(s) accordingly to register for the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: sdmis.nios.ac.in.
