The NIOS Examination of Vocational Education Courses is scheduled to be conducted during October-November, 2026. The Examination fee for the same will be accepted only through online mode. The examination fee is Rs. 400/- per subject/Module (Inclusive for Theory, Practical, and Internal Assessment, if any).

The Schedule for registration and payment of examination fee is as under:

Sl. No.	Fee Schedule	
1.	For all eligible learners	1st July, 2026 to 15th July, 2026 (without late fee)
2.	For all eligible learners with late fee of Rs. 150/- per subject	16th July, 2026 to 20th July, 2026 (with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1600/- per learners	21st July, 2026 to 25th July, 2026 (with consolidated late fee)

Note: Fee payment schedule for the learners registered for April-May, 2026 examination will be notified after the declaration of result in case result is not declared before 1st July, 2026.

All the Regional Directors are to note for compliance and also directed to intimate to the concerned AVIs for submission of Examination fee of Vocational Education Courses within the stipulated time. No offline fee will be accepted. The Regional Directors are requested to upload the Notification on their Regional Centre's website and also issue Press Release in the local dailies.
