3.	For all eligible learners with consolidated late fee of Rs. 1600/-per learners	21st July, 2026 to 25th July, 2026 (with consolidated late fee)
Note: Fee payment schedule for the learners registered for April-May, 2026 examination will be notified after the declaration of result in case result is not declared before 1st July, 2026.
