1. Period of Contract :

The contract shall remain valid for a period of one year i.e. from 01.04.2026 to 31.03.2027.

2. Submission of Quotation

- The quotation should be submitted in a sealed envelope superscribed as:

3. Scope of Work: The hired taxi may be required for:

- Official travel within Kochi city limits
- Travel to various districts within Kerala
- Occasional outstation official journeys

The vehicle shall be provided as and when required by the office.

4. General Terms and Conditions

- The vehicle provided must be in good running condition, well maintained, clean, and with valid registration, insurance, pollution certificate, and permit.
- The driver must possess a valid driving licence, good conduct, and adequate experience.
- The vehicle must report at the designated place and time as instructed by the office.
- The agency must comply with all applicable statutory requirements, including GST, labour laws, and transport regulations.
- The rates quoted should include all charges except toll and parking charges, which will be reimbursed on submission of valid receipts (if applicable).
- No advance payment shall be made. Payment will be processed after submission of bill and duty slip, duly certified by the concerned officer.
- The rates once accepted will remain valid for the entire contract period and no revision will be permitted.

5. Required Details: The quotation should include:

- Name and address of the firm/agency
- Contact number and email ID
- GST registration number (if applicable)
- Details of vehicles available with the agency
- Rate per kilometre / per day / waiting charges, etc. as per the prescribed pro forma.
