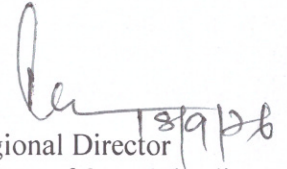
TERMS AND CONDITIONS:

1. The highest rates accepted for pulping will be valid up to 31-10-2027. The terms can be extended further only on the receiving written consent from the firm/tenderer.
2. The physical inspection of above items, quantity etc. to be weeded for pulping can be allowed to the interested parties on any working day (Monday to Friday) between 03:00 P.M. to 05:00 P.M. at the Regional Centre, Patna.
3. The Earnest Money of Rs 20,000/- (Rs. Twenty Thousand only) should be deposited by way of Bank Draft Drawn from Nationalized Bank in favor of "Regional Director, NIOS", payable at "Patna" along with the sealed quotation as per Annexure-1, without which quotations will not be considered and rejected.
4. The Demand Draft (DD) must be issued on or after 18.09.2026. DD issued prior to 18.09.2026 shall not be accepted.
5. The awarded agency shall deposit a Security deposit amount of Rs. 20,000/- (Rs. Twenty Thousand only) should be deposited by way of Bank Draft Drawn from Nationalized Bank in favor of "Regional Director, NIOS", payable at "Patna" which be refunded after completion of the tender period.
6. The Sealed Quotation along with requisite EMD duly sealed in double cover should be dropped in the Box available at the Account Department of the National Institute of Open Schooling, Regional Centre, Patna by 09.10.2026 up to 12:30 P.M.
7. Opening of Sealed Quotations will take place on 09.10.2026 at 02:30 P.M. in the NIOS Regional Centre, Patna in the presence of the representative of the firms/tenders, who may wish to be present at that time. No separate intimation will be sent to the firms/tenderers in this regard.
8. Amongst the tenderers the highest rate quoted against each group will be considered for acceptance.
9. The firm (s) whose highest rate offer is accepted will have to deposit 90% of the estimated cost of item(s) to be lifted to the Regional Director, National Institute of Open Schooling, Patna by way of Bank draft drawn from Nationalized Bank in favor of Regional Director, NIOS payable at Patna prior to lifting of the item(s) for pulping.
10. The firm (s) will have to fix the date and time of lifting of waste material with the authorized committee of the National Institute of Open Schooling. Lifting of waste material will be allowed in the presence of the Committee.
11. For weighing of the goods/items, the facilities of Dharma Kanta available nearby to Regional Centre, should be used. The payment for this purpose will be made by the firms.

12. Prior to weighment of the material, the weighment of the empty vehicle in which the goods will be loaded is required to be carried out.
13. Earnest Money Deposit as well as 90% estimated cost of goods deposited by the firms (s) to National Institute of Open Schooling will be liable to the forfeited, if the materials are not lifted by the firm as per the schedule fixed by the authorized Committee of National Institute of Open Schooling.
14. No labour or labour charges for loading-unloading of the goods required to be lifted will be provided by National Institute of Open Schooling.
15. A certificate in respect of re-pulping of papers is to be submitted by the agency within 15 days of lifting of materials to the Regional Director, NIOS, Regional Centre, Patna.
16. National Institute of Open Schooling reserves the right to reject any or all the Tenders/Quotations without assigning any reason thereof.
17. The firm (s) will have to lift the goods irrespective of the quantity of good available, which may be small or huge.
18. GST is applicable as per government norms.
19. For any dispute, if arises, an arbitrator will be appointed by the NIOS competent authority, whose decision will be final. The court's jurisdiction of any dispute will be at Patna.

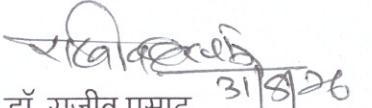
